# **FOREWORD**

## **OPENING CEREMONY**

The Thirtieth General Assembly of the Parliamentary Assembly of the Organization of the Black Sea Economic Cooperation was held in Tbilisi on 10-12 December 2007 upon the invitation of the Parliament of Georgia.

The Plenary Session was opened by Mr. Mikheil MACHAVARIANI, Acting Chairman of the Parliament of Georgia, PABSEC Vice-President. The BSEC Chairmanship-in-Office message addressed to the General Assembly was presented by Mr. Kostyantyn Yelisieiev, Deputy Minister of Foreign Affairs of Ukraine.

#### **PARTICIPATION**

## THE PLENARY SESSION

#### 1. General debate.

The topic of the General Debate was "Contribution of Energy Security to Economic Growth and Overall Security in the Black Sea Region".

The heads and members of the National PABSEC Delegations, Senate of the French Republic, representatives of the IPA EurAsEC and the PAUBR, took part in the General Debate, referring to the experience of their countries and organisations within the context of energy security.

The participants stated that currently the relevance of these issues on the political and economic agenda of the Black Sea region, as well as the necessity to fully utilise the transit potential of the area are obvious.

They mentioned the strategic importance of the Black Sea region as a production and transmission area, as well as the need for diversification and security of energy supply not only of the energy transport corridors, but also of the energy sources. Due to the current environmental situation in the Black Sea region, the speakers urged the BSEC Member States to develop and use friendly environmental technologies in the field of energy, and to enhance the cooperation in order to fight against the climate change.

During the debate, it was launched the idea of creating a common data base in the field of energy strategy. The speakers stressed that due to the fact that the current resources are limited, it is vital to think about the future and through collaboration and cooperation, to find new sources of energy. The Russian PABSEC Delegation expressed its readiness to prepare a report on this issue.

The participants also referred to the adoption by the EP on 26 September 2007 of the Resolution "Towards a Common European Foreign Policy on Energy", conceived as a contribution to the guaranteeing energy security for the whole of the EU and ensuring the sustainability at international level.

The speakers highlighted that given the energy interdependence of all Black Sea countries and their key role in the transit and supply of goods, regional cooperation in the field of energy has become crucial during the recent years. The growing significance of the region in the world energy market must be properly assessed and realized by all concerned parties in order to create reliable and effective coordination activities in the energy sector. The participants welcomed the initiative by the Ukrainian BSEC Chairmanship-in-Office to organize a Meeting of the Ministers of Energy in Kyiv in March 2008.
