## FOREWORD

### THIRTY-FOURTH GENERAL ASSEMBLY

#### OPENING CEREMONY

The Thirty-Fourth General Assembly of the Parliamentary Assembly of the Organization of the Black Sea Economic Cooperation was held in Moscow on 23 – 25 November 2009 upon the invitation of the State Duma of the Federal Assembly of the Russian Federation. The Plenary Session was opened by Mr. Boris Gryzlov, PABSEC President, Chairman of the State Duma of the Federal Assembly of the Russian Federation, who delivered the message of H.E. Mr. Dimitri Medvedev, President of the Russian Federation. The message of H.E. Mrs. Rumiana Jeleva, Chairman-in-Office of the Organization of the Black Sea Economic Cooperation, Minister of Foreign Affairs of the Republic of Bulgaria, was delivered by Mr. Plamen Grozdanov, Ambassador Extraordinary and Plenipotentiary of the Republic of Bulgaria to the Russian Federation.

## **THE 34th PLENARY SESSION**

### **1. *General debate.***

The topic of the General Debate was “The development of international transport corridors and ensuring energy security of the BSEC countries and Europe”.

The Chairmen of the Parliaments and the Heads of the PABSEC national delegations, representatives of the National Assembly of the Republic of Belarus, the Parliament of the French Republic, EP, OSCE PA, AWEU, CEI PD and PUIC took part in the General Debate.

The participants underlined the importance of efficient use of the geopolitical location of the Black Sea region. It was stressed that current developments in the region are to a great extent shaped according to the diversification of former transportation routes and strengthening of energy factor in the politics.

It was noted that as a result of the global financial and economic crisis, the system of international relations has revealed a need for renovation and “reset”. This is reflected also at regional level where further development of the infrastructure in the BSEC states, fuller use of the transit potential and utilization of Euro-Asian transport corridors acquire a greater significance.

It was noted that energy security is an important element in the policies of each state and that a long-term and closer cooperation between states is necessary to ensure energy security. Development of international transport corridors, as well as implementation of priority projects regarding transport corridors in the BSEC region meet the economic interests of both the BSEC states and the international community.

The speakers also noted the importance of the integration of transport systems and the necessity to continue the realisation of the projects connecting transport systems of the countries of the EU, Eastern Europe, Central Asia and Middle East. It was stressed that the availability of transport communications will pave the way towards deepening mutually beneficial cooperation in the Black Sea region and, respectively, towards strengthening mutual understanding in political issues.
