SUMMARY

FORTY-SEVENTH GENERAL ASSEMBLY

OPENING CEREMONY

The Forty-Seventh General Assembly of the Parliamentary Assembly of the Black Sea Economic Cooperation was held in Moscow, on 28-30 June 2016 upon the invitation of the State Duma of the Federal Assembly of the Russian Federation.

The Plenary Session was opened by Mr. Sergey Naryshkin, PABSEC President, Chairman of the State Duma of the Federal Assembly of the Russian Federation. Mr. Vladimir Putin, President of the Russian Federation and Mr. Sergey Lavrov, Minister of Foreign Affairs of the Russian Federation, Chairman-in-Office of the BSEC, addressed messages to the participants and guests in the Session.

PARTICIPATION

THE 47th PLENARY SESSION

1. General Debate

The topic of the General Debate was *Through Economic Cooperation to Peace, Stability and Prosperity in the BSEC Region*.

During the discussions, the participants have underlined the fact that this subject is of utmost importance for the Black Sea Region. Promoting dialogue among the PABSEC and the BSEC Members States, developing transport connections, increasing the volume of trade and attracting investments are considered to be the main factors for prosperity and growth in the Region.

They underlined that the Black Sea Economic Cooperation is a constituent part of the European architecture, and in this regard it is vital to attach importance to the Eastern Partnership, the Black Sea Synergy and the EU Strategy for the Black Sea.

The officials who have taken part in the debates stressed the fact that cooperation can be achieved through the implementation of the existing mutual beneficial joint projects aiming at strengthening multilateral cooperation in the Black Sea Region.

Members of the PABSEC national delegations emphasized that the dialogue should include the efforts of the governments to further continue working on building transport infrastructure, harmonizing related legislation of the member states and achieving interoperability in the Black Sea Region countries.

In conclusion, the speakers stressed upon the fact that the key mission of the PABSEC is to actively contribute, through multilateral parliamentary interaction, to the development and further promotion of economic cooperation among the countries by further developing its activity, and considering itself as a serious factor for strengthening the climate of mutual understanding and stability in the Black Sea Region.
